

RESOLUTION

WHEREAS, the Stormwater Management Act 167 of 1978 provides for the regulation of land and water use for flood control and stormwater management, requires the Pennsylvania Department of Environmental Protection to designate watersheds, and provides for grants to be appropriated and administered by the Department for plan preparation and implementation costs, and provides that each county will prepare and adopt a watershed stormwater management plan for each designated watershed; and

WHEREAS, the purpose of the Pennypack and Poquessing Creeks Watershed Stormwater Management Plans are to protect public health and safety and to prevent or mitigate the adverse impacts related to the conveyance of excessive rates and volumes of stormwater runoff by providing for the management of stormwater runoff and control of erosion and sedimentation; and

WHEREAS, design criteria and standards of stormwater management systems and facilities within the Pennypack and Poquessing Creeks Watersheds shall utilize the criteria and standards as found in the watershed stormwater management plan;

WHEREAS; the City of Philadelphia Water Department has been authorized under the ordinances of the City of Philadelphia to develop regulations for the management of stormwater and to review stormwater management plans for development within the City of Philadelphia;

NOW, THEREFORE, BE IT RESOLVED that the City of Philadelphia, acting through its Water Department, hereby adopts the Pennypack and Poquessing Creeks Watershed Stormwater Management Plans, including all volumes, figures, appendices, and model ordinance and forwards the Plan to the Stormwater Management Section of the Pennsylvania Department of Environmental Protection for approval.

On the motion of Vice Chair Richards, seconded by Commissioner Castor, it was unanimously adopted that:

WHEREAS, Act 167, the Stormwater Management Act requires Montgomery County to develop stormwater management plans for the designated watersheds in the county, and

WHEREAS, certain watersheds are located in more than one county, as in the case of the following four watersheds:

Pennypack Creek watershed (Montgomery and Philadelphia Counties) Poquessing Creek watershed (Montgomery and Philadelphia Counties) Perkiomen headwaters (Montgomery and Lehigh Counties) Valley Creek watershed (Montgomery and Chester Counties)

WHEREAS, stormwater management plans have been prepared jointly for these four watersheds by the counties in which the watersheds are located, and

WHEREAS, the stormwater management plans contain the information, standards and criteria for controlling stormwater within the watershed based on an evaluation of watershed data, as required by Act 167, and

WHEREAS, in accordance with Act 167, joint public hearings were held for the stormwater management plans for each of the four watersheds on the following dates:

Pennypack Creek watershed: June 14, 2011 Poquessing Creek watershed: July 10, 2012 Perkiomen headwaters: July 5, 2012 Valley Creek watershed; July 13, 2012, and

WHEREAS, none of the public comments received require revisions to any of the stormwater management plans, which are therefore considered to be complete and ready for adoption by the Commissioners of Montgomery County and submission to the State Department of Environmental Protection for approval.

NOW, THEREFORE, BE IT RESOLVED, that the Montgomery County Commissioners hereby adopt the Pennypack Creek Watershed Stormwater Management Plan, the Poquessing Creek Watershed Stormwater Management Plan, the Perkiomen Headwaters Stormwater Management Plan, and the Valley Creek Watershed Stormwater Management Plan.
